Instructions:

Appointment of a proxy

The appointment of a proxy relates only to AGM business. A Voting Member is entitled to attend and vote at the AGM, and is entitled to appoint a proxy to attend the AGM and vote on their behalf on any resolution or procedural motions which may be proposed at the AGM.

How to appoint and lodge a proxy

If you wish to appoint the Chair of the AGM as your proxy, mark the appropriate box. If you wish to appoint a person other than the Chair of the AGM as your proxy, please insert the name of that person in the space provided. If you leave this section blank, or your named proxy does not attend the AGM, the Chair of the AGM will be your proxy. A proxy need not be a Member of NSWWC.

How do I vote on items of business?

You may direct your proxy how to vote by placing a mark in one of the boxes opposite the resolution. If you do not mark any of the boxes opposite the resolution, your proxy may vote as he or she decides. If you mark more than one box opposite the resolution, your vote on the resolution will be invalid.
