

Artform-Specific Career Stage Guidance

Please read these descriptors carefully and nominate the career stage that most closely fits where you are in your practice right now. For each cell below, applicants at this stage typically demonstrate one or more of the indicators listed; you do not need to demonstrate every descriptor.

Self-published works are accepted. • Five or more illustrated works published or commissioned in contexts with editorial oversight. • A demonstrable body of public-facing illustration work: at least one solo exhibition or three group exhibitions at recognised galleries, festivals, art venues, or as part of cultural arts programs, or through a 	<ul style="list-style-type: none"> • Two or more full-length illustrated books published, at least one of which must be by a trade or small press. Recognised cultural arts programs that produce illustrated publications with editorial oversight also count toward this requirement. 	<ul style="list-style-type: none"> • Four or more full-length illustrated books over a sustained career, at least two of which must be by a trade or small press, or through recognised cultural arts programs producing illustrated publications with editorial oversight. • A major award win (CBCA Book of the Year, or equivalent).

<p>Playwrights</p> <p><i>In scope: writing for live theatrical performance: plays for stage, musical theatre books and libretti, and other forms of theatrical writing.</i></p> <p><i>Not in scope: screenwriting for film, television, or streaming.</i></p>	<ul style="list-style-type: none"> • One full-length play professionally produced by a theatre company, festival, or recognised independent venue. • Two or more short-form works produced in professional or recognised independent contexts. • Substantial engagement with one or more recognised playwright development programs (e.g., APT, MerringongX, Griffin development programs, ATYP playwright streams). 	<ul style="list-style-type: none"> • Two or more full-length plays professionally produced (any combination of mainstage, festival, or recognised independent contexts). 	<ul style="list-style-type: none"> • Sustained body of professionally produced work (four or more full-length productions). • A major industry award win (David Williamson Prize, Nick Enright Prize for Playwriting, or equivalent).

Note: career stage is self-nominated by applicants. The assessment panel may flag, during individual scoring, where an applicant appears to be in the wrong career stage AND would be rated highly at a different stage; in those cases the application may be reassigned by the panel Chair and re-scored at the new stage before the panel meeting. Self-publishing is accepted at all tiers, with the trade or small press requirements above applying at mid-career and established.
